Re: Legal Aid No GELCGAPY3440/A/L/2 Myself v Bradford & Bingley Building Society

I was surprised to discover from my acting solicitors, that the Legal Aid Board would not be prepared to pay for a forensic report in relation to the above numbered case.

As you are aware the basis of my case against the Defendant is the belief that they have fraudulently compiled a mortgage account in my name and that I have the legal right to an independent examination of that account.

Following the Defendants Appeal against the Order of District Judge Turner, a court hearing was scheduled for the 15th December 1999. At the request of District Judge Turner a Chancery Judge was to examine the evidence. It was for this hearing that I was informed by my solicitors that the Legal Aid Board would not be prepared to pay the cost of a forensic analysis and report in my case.

The scheduled hearing was subsequently heard before Chancery Judge Maddox who has deferred his judgement in order to examine the evidence. In my opinion, the said evidence should have been accompanied by a supportive forensic report.

Prior to the hearing, we were informed by Grant Thornton. Accountants, that a report could be provided at a cost of between £500.00 and £750.00, and that there were serious discrepancies within the Defendants accounts which warranted explanation. My solicitor was duly informed Clearly Judge Turner's request for a Chancery Judge was indicative of the need for a forensic analysis of my evidence and also that the issues to be raised were monetary. I am concerned, that the deprivation of such supportive evidence could have an adverse affect on the outcome of my ease.

As I may yet require such support for future court hearings I would appreciate your comments regarding my position as a legally aided litigant.
